







About Harmonic


Headquartered in Camden UK, with additional offices in Manchester and Boston USA, Harmonic Group is composed of Harmonic Finance & Harmonic Operations.




With our colleagues front of mind, Harmonic partner with The Circle Line (an employee mental health platform) to give the team 24/7 access to online therapy and coaching.






Our Process


